

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to 3940 S. Ferree and Epoxy Coating Specialists (ECS) and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Epoxy Coating Specialists (ECS) include 3940 S. Ferree and ECS. The ECS website is a business and flooring contractor site. By using the ECS website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, ECS may collect personally identifiable information, such as your:

All such third parties are prohibited from using your personal information except to provide these services to ECS, and they are required to maintain the confidentiality of your information.

Tracking User Behavior

Lead Forensics

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by ECS. Use of Cookies
